MIKE MINNICK FOREST CONSERVATION SCHOLARSHIP

PURPOSE: To assist a student pursuing a degree in forestry, wildlife, fisheries, soil science or closely related field.

DUE DATE: Applications must be received by May 1 at:

AWARD: Selection will be made by May 31st.

One \$500 scholarship will be awarded per year, based funding availability.

ELIGIBILITY:

1. Must be a resident of Garrett County, MD.
2. Must have completed high school or GED (or be a graduating high school senior during the year of application).
3. Must have declared a major in forestry, wildlife, fisheries, soil science or a closely related field, at the discretion of the Garrett County Forestry Board.
4. Must have high school GPA of 2.5 or greater if entering first year of college. Must have college GPA of 2.5 or greater if already in college.
5. Previous recipients are eligible, but preference will be given to first time applicants.



Mike Minnick served as chair of the Garrett County Forestry Board from 2015-2024 and was passionate about the Forestry Board and natural resources education. He was a driving force behind the establishment of the scholarship program in 2020. After his passing in 2024, this scholarship was renamed the Mike Minnick Forest Conservation Scholarship to honor his legacy.
